Our client is a global group of energy and petrochemical companies with about 84,000 employees across more than 70 countries. They aim to meet the world's growing need for more and cleaner energy solutions in ways that are economically, environmentally, and socially responsible. Our client has identified an immediate need for a Commissioning and Startup Permit-to-Work (PTW) | Safety Isolation (SI) Mentor for their polymer production facility in the greater Pittsburgh, PA area. This contract position has an anticipated duration of 6-12 months.

COMPANY INFORMATION:

Our client has recently constructed petrochemical complex in Western Pennsylvania. The overall site measures approximately 800 acres - with a core manufacturing and logistics area of approximately 386 acres. The site is located along the Ohio River in Potter Township, Beaver County - approximately 30 miles northwest of Pittsburgh. This production facility will produce Linear low-density polyethylene (LLDPE) which is the primary raw material for items like flexible food packaging and pouches, collation shrink wrap, stretch film, protective packaging, flexible tubing, sports equipment (canoes), industrial equipment (tornado shelters), wire and cable insulation, agricultural films; and High-density polyethylene (HDPE) that is used to create "stiffer" products such as toys, crates, drums, shampoo bottles, milk jugs, detergent/bleach bottles, pails (buckets), environmental liners, paint containers, garden furniture and other types of housewares. The Beaver petrochemical complex includes:

- Ethylene Cracker Unit,
- > Three Polyethylene units with a combined production capacity of 3.5 billion pounds,
- 250 Megawatt Cogen Plant to power the site

As construction of the site progresses, the site is now growing to support Commissioning and Start-Up activities and prepare for full operation. The Commissioning and Startup PTW|SI Mentor is:

- Responsible for developing competency within the Logistics production team
- Will teach, coach, and develop skill related to permit to work and safe isolation principles
- Acts as an expert in Permit-to-Work and Safe Isolation with broad and technical expertise in this space
- Will be part of the PTW/SI Tactical Team to deliver training, field support and assurance reviews through Product in Tank (PIT)
- Will support Operations, Maintenance, Logistics, Laboratories and other areas where PTW/SI support is needed
- Will support implementation of Permit Vision®
- Will support the PTW/SI Project Director
- Executes complex activities with broad guidelines and instructions to ensure effective implementation of PTW/SI
- May help supervise some of the other PTW/SI Coaches.
- Work with Internal stakeholders in the planning and execution for Permit-to-Work and Safe Isolation initiatives.
- Help with the development Operators, Crafts, Front Line Leaders and contractors in the PTW/SI space.
